 - 4) a sample Asset Backed Securities certificate;
 - 5) a legal opinion;
 - 6) Financial reports on the Asset Backed Securities Collective Investment Contract that has been audited by an Accountant; and
 - 7) documents that contain the results of the rating from a rating agency licensed by Bapepam.
- 2. If the Registration Statement referred to in number 1 letter a of this rule has or has not fulfilled the requirements, Bapepam shall notify the applicant stating that:
 - a. the Registration Statement is incomplete using Form Number IX.C.9-2, attachment 2 of this rule; or
 - b. the Registration Statement is declared effective by Bapepam, using Form Number IX.C.9-3, attachment 3 of this rule.
