That based on the above considerations, it is deemed necessary to revise Rule Number X.N.1, Attachment of Decision of the Chairman of Capital Market and Financial Institutions Supervisory Agency Number Kep-347/BL/2008 concerning Investment Manager Monthly Activities Reports, by enacting new Decision of the Capital Market and Financial Institutions Supervisory Agency;

HAS DECIDED:

Article 1

Provision concerning Investment Manager Monthly Activities Reports is regulated in Rule Number X.N.1 as stipulated in the attachment of this Decision.

Article 2

With the enactment of this Decision:

A. Provisions number 2 until 5 of rule of the Capital Market Supervisory Agency Number II.A.3, Attachment of Decision of the Chairman of Capital Market Supervisory Agency Number Kep-41/PM/1997 dated 26 December 1997 concerning Letters, Reports and Other Documents that are Sent to the Capital Market Supervisory Agency, is declared not applicable for submission of the Investment Manager monthly activities reports, since the date of expiration of the implementation trial period of Rule Number X.N.1 Attachment of this Decision and/or since the Capital Market and Financial Institutions Supervisory Agency does not declare and

announce that electronic system utilized for submitting the Investment Manager monthly activities reports is impaired and cannot be used; and

B. Rule Number X.N.1 Attachment of Decision of the Chairman of Capital Market and Financial Institutions Supervisory Agency Number Kep-347/BL/2008 dated 13 August 2008 concerning Investment Manager Monthly Activities Reports is declared revoked and not applicable.

Article 3

- (1) Investment Manager who acquired business license from the Capital Market and Financial Institutions Supervisory Agency before this Decision becomes effective, must perform a trial to submit the Investment Manager monthly activities reports electronically as regulated in Rule Number X.N.1 Attachment of this Decision within 3 (three) reporting periods after the enactment of this Decision.
- (2) During the trial period as referred to the point (1), the Investment Manager must submit the monthly activities reports as regulated in Rule Number X.N.1 Attachment of this Decision to the Capital Market and Financial Institutions Supervisory Agency in hard copy, which in line with Rule of the Capital Market Supervisory Agency Number II.A.3 Attachment of Decision of the Chairman of Capital Market Supervisory Agency Number Kep-41/PM/1997 dated 26 December 1997 concerning Letters, Reports and Other Documents that are Sent to the Capital Market Supervisory Agency.

Article 4

With the enactment of this Decision, provision number 7 letter c of rule of the Capital Market Supervisory Agency Number II.A.1, Attachment of Decision of the Chairman of Capital Market Supervisory Agency Number Kep-39/PM/1997 concerning Public Documents that Open to the Public is not applicable.

RULE NUMBER X.N.1 : INVESTMENT MANAGER MONTHLY ACTIVITIES REPORTS

- 1. Every Investment Manager must submit monthly activities reports to the Capital Market and Financial Institutions Supervisory Agency (CMFISA).
- 2. The monthly activities reports as referred to in number 1 must be prepared using Form Number X.N.1-1 attachment of this Rule.
- 3. The monthly activities reports as referred to the number 1 must be submitted through electronic system to the CMFISA no later than on the twelfth of the following month. If the twelfth of the following month is a holiday, the monthly activities reports must be submitted on the following working day.
- 4. The electronic system as referred to the number 3 can be accessed by the Investment Manager by entering report data in the available form on http://aria.bapepam.go.id/ by first fulfilling member ID, user ID, and password in login form.

The member ID, user ID, and password are issued by the CMFISA to the Investment Manager.

- 5. The Investment Manager must keep electronic proof of acceptance of the monthly activities reports from the appointed system by the CMFISA and electronic documents of the monthly activities reports for at least 10 (ten) years.
- 6. The monthly activities reports as referred to in number 1 is considered accepted by the CMFISA based on minute, hour, date, month and year on the display of electronic proof of acceptance of the monthly activities reports as referred to in number 4 above.
- 7. In case of the CMFISA declares and announces that the electronic system as referred to in number 3 is impaired and cannot be used, the Investment Manager monthly activities reports must be submitted according to Rule Number II.A.3 concerning Letters, Reports and Other Documents that are Submitted to the Capital Market Supervisory Agency.
