## REGARDING ADMINISTRATIVE SANCTION SUSPENSION OF NOTIFICATION OF REGISTRATION FOR 6 (SIX) CAPITAL MARKET LEGAL CONSULTANTS

Board of Commissioners of the Financial Services Authority (OJK), through letter of decision on administrative sanction for violation against law in the field of capital market (attached), has issued letter of decision on suspension of notification of registration (STTD) for 6 (six) capital market legal consultants (KHPM) registered in OJK. This decision is a follow-up measure to respond to result of OJK's examination on violation against stipulation point 11 letter a jo. point 17 of Regulation Number VIII.B.1, Appendix Decision of Chairman of Capital Market and Financial Institution Supervisory Agency (Bapepam-LK) Number Kep-16/BL/2011 dated January 18, 2011 on registration for legal consultants working in capital market, since the 6 (six) capital market legal consultants are found to have not taken continuing professional education (PPL) with a minimum of 5 (five) professional credit units (SKP) in 2 (two) consecutive years, or 3 (three) times of education in 5 (five) years.
