- 1. A public Notary must be registered with Bapepam and fulfill the requirements stipulated in this rule in order to provide professional services in the Capital Market.
- 2. The requirements for a public Notary referred to in item 1 are as follows:
 - a. be authorized by the Minister of Justice and have been sworn in by the authorized agency;
 - b. not have committed a disgraceful act and or been found guilty of a criminal act in the financial sector;
 - c. have good character and morals;
 - d. have expertise in Capital Market, which may be fulfilled by attending training programs approved by Bapepam;
 - e. agree to attend continuing Advanced Professional Training (PPL) programs regarding Notary requirements and Capital Market rules;
 - f. agree to perform activities in accordance with the public Notary Rules and the professional codes of ethics, and always be independent;
 - g. be a member or agree to become a member of the Indonesian Notaries Association; and
 - h. agree to be inspected by the Indonesian Notary Association, regarding compliance with public Notary Rules (PJN) and the professional code of ethics.
 - 3. An application for Notary to be registered as a Capital Market Supporting Professional shall be submitted to Bapepam in 4 (four) copies, using Form Number VIII.D.1-1 attachment 1 of this rule.
 - 4. The registration application referred to in item 3 of this rule, shall be accompanied by the following documents:
 - a. the tax registration number;
 - b. the appointment decision as a public Notary from the Minister of Justice and public Notary oath from authorized agency;
 - c. a statement that the public Notary has never committed a disgraceful act and or been found guilty of a criminal act in the financial sector;
 - d. a certificate from a Capital Market training program approved by Bapepam;
 - e. a statement agreeing to attend continuing Advanced Professional Training (PPL) programs regarding notary requirements and Capital Market rules;
 - f. a statement agreeing to perform activities in accordance with the public Notary Rules, the

professional code of ethics, and to be independent;

- g. proof of membership in Indonesian Notaries Association, (if any);
- h. a statement that the Notary is willing to become a member of the Indonesian Notary Association upon receiving a Registration Letter from Bapepam and to submit evidence of such membership to Bapepam; and
- i. a statement agreeing to be inspected by the Indonesian Notary Association, with respect to compliance with public Notary rules and the professional code of ethics.
- 5. If the application referred to in item 3 of this rule is incomplete, no later than 45 (forty five) days after the submission of the application, Bapepam must give a notice to the applicant, which states that:
 - a. the application is not complete, using Form Number VIII.D.1-2, attachment 2 of this rule; or
 - b. the application is rejected, using Form Number VIII.D.1-3, attachment 3 of this rule.
- 6. If the application referred to in item 3 of this rule is complete, no later than 45 (forty five) days after the submission of the application, Bapepam will issue a Capital Market Supporting Professional Registration Letter to the applicant, using Form Number VIII.D.1-4, attachment 4 of this rule.
- 7. Any change with respect to data and information from the public Notary must be reported to Bapepam no later than 14 (fourteen) days after the change occurs.
